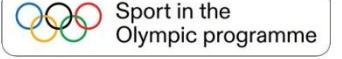

Show Cause Notice – Indulging in unauthorized sport activity

In continuation with our circular no **TNRSA / 2022 / 09 / 25** dated **25th Sep. 2022**

Show Cause notice will be issued to the following individuals and clubs.

1. All the Registered Skaters who participated in the recent unauthorized championship
2. Clubs & District Units Involved in Unauthorized Sport Events

If it is reported against you that you are involved in other sport / unauthorized sport activity without taking prior permission from TNRSA; It is subject to disciplinary actions under the rules and regulations of TNRSA / RSFI. Being a part of club & district unit you cannot entertain this kind of activities.

Accordingly, you might be called upon to submit your written explanation and show cause why disciplinary action should not be taken against you within 7 days. In such cases failure of response will be considered as you accept your fault and serious action will be taken.

Any Skater, Club, District involving in unauthorized sport activity will not be allowed in upcoming Club, District, State, National & International Championships and selection trials atleast for 3 Years.
